TERMS OF REFERENCE

APPOINTMENT OF AUCTIONEER FOR THE PUBLIC AUCTIONING OF TWO (2) SAHRA BOATS

1. PURPOSE

The South African Heritage Resources Agency (SAHRA) hereby invites suitably qualified auctioneers registered with the South African Institute of Auctioneers and in possession of a valid Fidelity Fund Certificate for the public auctioning of two (2) SAHRA boats.

2. BACKGROUND

- 2.1 The South African Heritage Resources Agency (SAHRA) is an agency of the Department of Arts and Culture and is the national administrative body responsible for the management and protection of South Africa's cultural heritage resources.
- 2.2 SAHRA has amongst its assets two boats for the MUCH Unit. SAHRA has approved disposal of these boats through a public auction. It is on this background that quotations are invited from auctioneers registered with the South African Institute of Auctioneers and in possession of a valid Fidelity Fund Certificate for the public auctioning of these boats.

3. SCOPE OF SERVICES

3.1 SAHRA wishes to invite auctioneers registered with the South African Institute of Auctioneers and in possession of a valid Fidelity Fund Certificate to submit a closed quotation for the public auctioning of the following two vessels:

3.2 Wreck Sentinel boat measuring about 8,9m Buttcat with two Suzuki outboard motors (**Figure 1**) through a rental agreement. The boat does not have a trailer. Its registration number is DTC81718. Located at Strand.

3.3 9m semi-rigid inflatable on a trailer, with a three-litre inboard Mercruiser engine (**Figure 2**). Its registration number is UB9307. Located at Kirstenhof, Cape Town.

4. REQUIREMENTS TO BE INCLUDED IN THE SUBMISSIONS

To guarantee an objective and fair evaluation process, all proposals submitted must be in accordance with the format as described in the scope of work. The following must be included in your document:

1. The commission, expressed as a percentage on the selling price, plus VAT, and any other fees that will be charged to handle the auction.
2. A description of the proposed marketing process (how and where), including time frames, as well as the estimated expenditure by the auctioneer to market the auction.
3. Any other services in support of the quotation that the bidder will/can provide.
4. The names and contact details of at least three contactable references that services were provided for in the last six months.
5. Proof of registration with the South African Institute of Auctioneers.
6. Certified copy of Fidelity Fund Certificate.

Failure to provide all or any part of the requested information in the required format may result in a proposal being excluded from the evaluation process.

5. TERMS AND CONDITIONS OF TENDERING

- 5.1 All costs and expenses incurred by the potential service provider relating to their project proposal will be borne by each respective service provider. SAHRA is not liable to pay such costs and expenses or to reimburse or compensate service providers in the process under any circumstances, including the rejection of any proposal or the cancellation of this project.
- 5.2 SAHRA reserves the right to request new or additional information regarding each bidder and any individual or other persons associated with its proposal.
- 5.3 SAHRA may require responsive bidders to present and discuss their proposals in person.
- 5.4 SAHRA reserves the right not to make any appointment from the proposals submitted.
- 5.5 Bidders shall not issue any press release or other public announcement pertaining to details of their project proposal without the prior written approval of SAHRA.

- 5.6 Bidders are required to declare any conflict of interest they may have in the transaction for which the bid is submitted or any potential conflict of interest. It is important that bidders declare their conflict of interest through completion of relevant attached forms.
- 5.7 SAHRA reserves the right not to consider further any bid where such a conflict of interest exists or where such potential conflict of interest may arise.
- 5.8 All project proposals shall become the property of SAHRA and shall not be returned.
- 5.9 The bid offers, and proposals should be valid and open for acceptance by SAHRA for a period of 60 days from the date of submission.
- 5.10 Bidders are advised that submission of a proposal gives rise to no contractual obligations on the part of SAHRA.
- 5.11 SAHRA reserves the right not to award the bid to the bidder that scores the highest points.
- 5.12 Disputes that may arise between SAHRA and a bidder must be settled by means of mutual consultation, mediation (with or without legal representation) or, when unsuccessful, in a South African court of law.
- 5.13 In addition to adherence to the specific terms and conditions of proposals, provided in this document, the bidder shall be bound by the provisions of the General Conditions of Contract attached hereto, an original signed copy of which must be submitted together with all other bid documentation.
- 5.14 All returnable bid documents must be completed in full and submitted together with the bidder's proposal. Should the returnable documents not be completed, the bid will not be considered any further.
- 5.15 The successful bidder will be subject to supplier clearance process as prescribed by the National Treasury. This process includes verification of supplier and its shareholders/ directors/ members' status on the list of defaulters and restricted suppliers.
- 5.16 The proposal must include a company profile/ organization profile, comprising a description of the organization of the bidder, its primary business activity, clients experience, management etc, including at least three references for companies, to whom the service provider has supplied the same service.

5.17 After the successful service provider has received the purchase order, they must be able to deliver in full compliance with South African approved standards and in compliance to the specifications provided.

8. EVALUATION CRITERIA

8.1 All proposal offers received shall be evaluated based on the following phase out approach:

- **Phase one:** Compliance to the terms of reference and conditions of the tender. Failure to meet any of the conditions of the tender will automatically disqualify your tender on this phase.
- **Phase two:** preference points for Broad-Based Black Economic Empowerment (BBBEE) Status Level of Contribution (80/20 preference points system), where 80 points are allocated to price, and 20 points are allocated to BBBEE status level as follows:

9. Price (Vat included)

80 Points for price will be awarded with reference to the total fixed proposal amount inclusive of VAT. The service provider with the lowest price shall score the maximum 80 points.
