TERMS OF REFERENCE

THE SOUTH AFRICAN HERITAGE RESOURCES AGENCY (SAHRA) INVITES SUITABLY QUALIFIED SERVICE PROVIDERS TO SUBMIT QUOTATIONS FOR THE SUPPLY, ASSEMBLE AND PLACEMENT OF FURNITURE AND APPLIANCES IN STRUISBAAI FISHERMEN COTTAGES 7 AND 8 IN STRUISBAAI, WESTERN CAPE.

1. PURPOSE

- 1.1 The South African Heritage Resources Agency (SAHRA) invites suitably qualified Service providers to submit quotations for the supply, assemble and placement of furniture and appliances in Struisbaai Fishermen Cottages 7 and 8, in Struisbaai, Western Cape.

2. BACKGROUND

- 2.1 The South African Heritage Resources Agency (SAHRA) is an agency of the Department of Arts and Culture and is the national administrative body responsible for the management and protection of South Africa's cultural heritage resources.
- 2.2 SAHRA owns and manages thirty-six properties of heritage significance in South Africa. The Struisbaai Fishermen Cottages is one of the properties owned by SAHRA. Struisbaai is situated approximately 230 km east of the Cape Town CBD. It is a small rural and holiday town. It is located in the Cape Agulhas Municipality that includes the towns of Bredesdorp, Napier, Arniston, L'Agulhas and Suiderstrand.

The subject properties are located on the corner of Main Road and Argonauta Avenue on the northern periphery of Struisbaai as you enter the town.



- 2.3 The subject properties were donated to SAHRA for the preservation thereof as it consists of nine fisherman's cottages which are worthy of preservation in view of various architectural and historical consideration.

3. PROPERTY DETAILS:

- 3.1 Access to this site is from Main Road via a dirt road, more suitable for off-road vehicles.
- 3.2 Construction Material and Finishes:
Roof: Thatch roofing
Superstructure: Brick / stone with plaster & paint
Window frames: Timber window frames fitted with clear glass panes

4. SCOPE OF SERVICES

- 4.1 The furniture and appliances required is for Cottage 7 and Cottage 8a which includes a smaller separate dwelling 8b.
- 4.2 The list of furniture and appliance specifications is attached and may be of similar approved. Refer to **Annexure A**.
- 4.3 The service provider must include in his offer the supply of the specified furniture and appliances, delivery to the location in Struisbaai, the assembling of the goods, and the placement of the furniture and appliances as directed by the SAHRA representative on site.
- 4.4 The service provider must provide the timeframe from time of appointment to delivering, assembling and placement of furniture to the identified cottages.

5. TERMS AND CONDITIONS OF TENDERING

- 5.1 All costs and expenses incurred by potential service providers relating to their submission of the tender will be borne by each respective service provider. SAHRA is not liable to pay such costs and expenses or to reimburse or compensate service providers in the process under any circumstances, including the rejection of any tender or the cancellation of this project.

- 5.2 While SAHRA endeavours to ensure that all information provided to all potential service providers is accurate, it makes no warranty as to the accuracy or completeness of any information provided by it.
- 5.3 SAHRA reserves the right to waive deficiencies in project proposals/quotations. The decision as to whether a deficiency will be waived or will require the rejection of a project proposal/quotation will be solely within the discretion of SAHRA.
- 5.4 SAHRA reserves the right to request new or additional information regarding each service provider and any individual or other persons associated with its project proposal/quotations.
- 5.5 SAHRA reserves the right not to make any appointment from the tenders/quotations submitted.
- 5.6 Service providers shall not make available or disclose details pertaining to the tender/quotation with anyone not specifically involved, unless authorized to do so by SAHRA.
- 5.7 Service providers shall not issue any press release or other public announcement pertaining to details of their tender/quotation without the prior written approval of SAHRA.
- 5.8 Service providers are required to declare any conflict of interest they may have in the transaction for which the tender/quotation is submitted or any potential conflict of
- 5.9 interest. SAHRA reserves the right not to consider further any proposal and/or tender/quotation where such a conflict of interest exists or where such potential conflict of interest may arise.
- 5.10A valid original Tax Clearance Certificate, issued by the South African Revenue Services, must be submitted, failing which the relevant service provider's proposal shall not be considered. (See attached application form for Tax Clearance Certificate)
- 5.11 Any and all project proposals and/or tenders shall become the property of SAHRA and shall not be returned.

- 5.12 Service providers are advised that the submission of a proposal and/or tender gives rise to no contractual obligations on the part of SAHRA.
- 5.13 It is expected of service providers to familiarise themselves with the property before submitting their tender offer.
- 5.14 SAHRA reserves the right not to accept any proposal and/or tender which does not comply with the TERMS OF REFERENCE and conditions set out in the tender documents.
- 5.15 Please note that SAHRA will view every proposal and/or tender against the spirit and purpose of the National Heritage Resources Act No 25 of 1999.
- 5.16 SAHRA reserves the right not to award, or not award the proposal / tender to the service provider that scores the highest points.
- 5.17 Disputes that may arise between SAHRA and a service provider must be settled by means of mutual consultation, mediation (with or without legal representation) or, when unsuccessful, in a South African court of law.
- 5.18 All returnable proposal / tender documents must be completed in full and submitted together with the service provider's quote.
- 5.19 The "Requirements for content of the project proposal" section above outlines the information that must be included in proposal offers. Failure to provide all or part of the information may result in your proposal being excluded from the evaluation process.
- 5.20 All goods/service or products to be supplied to SAHRA shall be in full compliance with South African approved standards and in compliance to the specifications provided.
- 5.21 It is the conditions of this RFQ that, a quotation is submitted together with the following completed forms; kindly submit fully completed Bid Documents.

 - b) SBD 2 Tax Clearance certificate application form.
 - c) SBD 3.3 Pricing Schedule.

 - d) SBD 4 Declaration of Interests form.

- e) SBD 6.1 Preference points claim form (valid BBBEE certificate must be submitted together with this completed document.
 - f) Contract Form – Rendering of Services.
 - g) SBD 8 Declaration of Bidders SCM practices.
 - h) SBD 9 Declaration of independent bid determination.
 - i) General Conditions of Contract (**PLEASE INITIAL EACH PAGE, AS PROOF THAT THE BIDDER FAMILIARIZED THEMSELVES WITH THE CONTENT OF THE DOCUMENT**).
 - j) A valid Fidelity Fund Certificate.

NB: Failure to submit original completed returnable forms as mentioned above will automatically disqualify your quotation. Please ensure that you submit an original valid tax clearance certificate/ Tax pin.

5.22 SAHRA reserves the right to revise any aspect of these timeframes at any stage, and to amend the process at any stage.

6. EVALUATION CRITERIA

6.1 All proposal offers received shall be evaluated based on the following phase out approach:

- **Phase one:** Compliance to the terms of reference and conditions of the proposal / tender. Failure to meet any of the conditions of the proposal / tender will automatically disqualify your proposal / tender on this phase.
- **Phase two:** Prequalification criteria (Obtaining the minimum threshold for functionality as set out below)

A bidder must obtain a minimum of 60 points on the prequalification phase to progress to the next phase. Failure to obtain 60 points will render your proposal non-responsive.

- **Phase three:** preference points for Broad-Based Black Economic Empowerment (BBBEE) Status Level of Contribution (80/20 preference points system), where 80/90 points are allocated to price, and 20/10 points are allocated to BBBEE status level as follows:

7. PRICE (VAT INCLUDED)

80 Points for price will be awarded with reference to the Final Offer inclusive of VAT. The service provider with the lowest price shall score the maximum 80 points.
