TERMS OF REFERENCE

PROCUREMENT OF THE RENEWAL OF GFI LANGUARD SOFTWARE LICENCES FOR SAHRA

1. PURPOSE

1.1 The purpose of this procurement is to renew GFI LanGuard Software licenses for SAHRA for both patch and vulnerability management.

2. BACKGROUND

2.1 SAHRA currently makes use of GFI LanGuard software to do automated patch management. This is a maintenance intense exercise which is difficult to do effectively without software to manage the process.

2.2 SAHRA also uses this software to run vulnerability testing on its systems, which will allow for proactive implementation of security fixes. Having a software package to do this task, enables the ICT Team to proactively resolve security issues.

2.3 SAHRA currently has 160 node licenses, but now requires a total of 350 nodes.

2.4 Include on-line training for two people, as a separate line item in the software quote.

3. SCOPE AND SERVICES REQUIRED

3.1 The software license must be for 350 nodes.

3.2 Must provide a network security scanner.

3.3 Must provide a patch management solution that acts as a virtual security consultant.

3.4 Must do regular website scans to protect the website from cyber-attacks.

3.5 Must provide risk analysis of systems.

3.6 Must have a dashboard with all indicators.

3.7 Must provide training to ICT Staff at SAHRA

4. TERMS AND CONDITIONS OF PROPOSALS

4.1 Must be an annual renewable license.

4.2 SAHRA reserves the right not to make any appointment from the proposals submitted.

4.3 Bidders shall not issue any press release or other public announcement pertaining to details of their project proposal without the prior written approval of SAHRA.

4.4 Bidders are required to declare any conflict of interest they may have in the transaction for which the bid is submitted or any potential conflict of interest. It is important that bidders declare their conflict of interest through completion of relevant attached forms.

4.5 SAHRA reserves the right not to consider further any bid where such a conflict of interest exists or where such potential conflict of interest may arise.

4.6 Any and all project proposals shall become the property of SAHRA and shall not be returned.

4.7 Bidders are advised that submission of a proposal gives rise to no contractual obligations on the part of SAHRA.

4.8 SAHRA reserves the right not to award the bid to the bidder that scores the highest points.

4.9 Disputes that may arise between SAHRA and a bidder must be settled by means of mutual consultation, mediation (with or without legal representation) or, when unsuccessful, in a South African court of law.

4.10 In addition to adherence to the specific terms and conditions of proposals, provided in this document, the bidder shall be bound by the provisions of the General Conditions of Contract attached hereto, an original signed copy of which must be submitted together with all other bid documentation.

4.11 All returnable bid documents must be completed in full and submitted together with the bidder's proposal. Should the returnable documents not be completed, the bid will not be considered any further.

4.12 The successful bidder will be subject to supplier clearance process as prescribed by the National Treasury. This process includes verification of supplier and its shareholders/directors/members' status on the list of defaulters and restricted suppliers.

4.13 The proposal must include a company profile/ organization profile, comprising a description of the organization of the bidder, its primary business activity, clients experience, management etc, including at least three references for companies, to whom the service provider has supplied the same service.

4.14 After the successful service provider has received the purchase order, they must be able to deliver in full compliance with South African approved standards and in compliance to the specifications provided.

7.1.2 **Phase two:** preference points for Broad-Based Black Economic Empowerment (BBBEE) Status Level of Contribution (80/20 preference points system), where 80 points are allocated to price, and 20 points are allocated to BBBEE status level as follows;
