1. ROTHMAN HOUSE, CHURCH STREET, UTRECHT

### *Description:*

The property with the so-called Rothman House, thereon, being the remainder of Erf 244, Utrecht Township, situate in the Municipality and District of Utrecht, Province of Natal, in extent four thousand two hundred and four (4 204) square metres.
